I. CEO's Report Summary

1. Enrollment & Transportation

Transportation has significantly improved: KidzRide is now used for special cases, reducing Uber use. 19 of 21 previously unresolved transportation cases are now resolved, improving attendance and reliability.

2. Staffing & Retention

Mr. T'Juan Williams joins as Facilities Manager (starting Feb 24). The school maintains a 92% staff retention rate. A new leadership structure has been implemented through the appointment of grade-level leads, one for each grade. These leads facilitate morning meetings, provide peer coaching, and drive alignment in instructional practices. Their roles are part of the school's partnership with Transformation 180, supporting the development of internal leadership capacity and collaboration among staff. Each grade-level lead receives a \$3,750 stipend.

Next steps include hiring a Math Coach and potentially expanding Ms. Allen's role to include attendance specialist duties.

3. Truancy Policy

A new tiered truancy policy was implemented with automated communications and mandatory SAIP meetings. This supports the school's ATSI designation goals related to improving attendance.

4. Technology Integration

Chromebook rollout completed, achieving a 1:1 ratio. Inventory also finalized. Investment includes \$74,700 in Chromebooks and \$11,586.10/month for IT services from Spera Partners.

5. Behavioral Supports

Behavior Matrix updated to support Diverse Learners with tailored interventions and consequences, improving inclusivity.

6. Facilities & Real Estate

Variance hearing for expanding to the 5th and 6th floors occurred Feb 18. If denied, alternative renovations to the existing space will proceed, with projected costs between \$600K-\$1.1M.

7. Hiring Philosophy

A new hiring approach and job postings were developed in collaboration with Transformation 180 to better align hires with the school's mission and culture. HBK will support hiring practices.

8. Compliance

Three audits were successfully completed: PPS, PDE Special Education, and PDE Food Service, affirming strong operational standards.

9. SchoolMint Grow (Professional Development)

SchoolMint Grow replaced PAETEP as the teacher observation tool, providing evidence-based, growth-focused coaching. Annual investment: \$6,642.50.

10. HR Operations & UKG Implementation

HBK is now managing HR functions and will integrate UKG for payroll, evaluations, and scheduling. This enhances transparency and efficiency.

11. Strong Mind Solutions Partnership

Group therapy (22-student caseload) has improved student emotional regulation and behavior. Ongoing investment supports student mental health at \$64.50/hour.

12. Financial Health

Despite a YTD net income loss of \$80,764 due to lower enrollment revenue, the school remains fiscally strong:

- Current Ratio: 8.15 (Standard: 1.1)
- Cash on Hand: 211.52 days (Standard: 45 days)
- Debt Ratio: 0.46 (Standard: <0.85)
